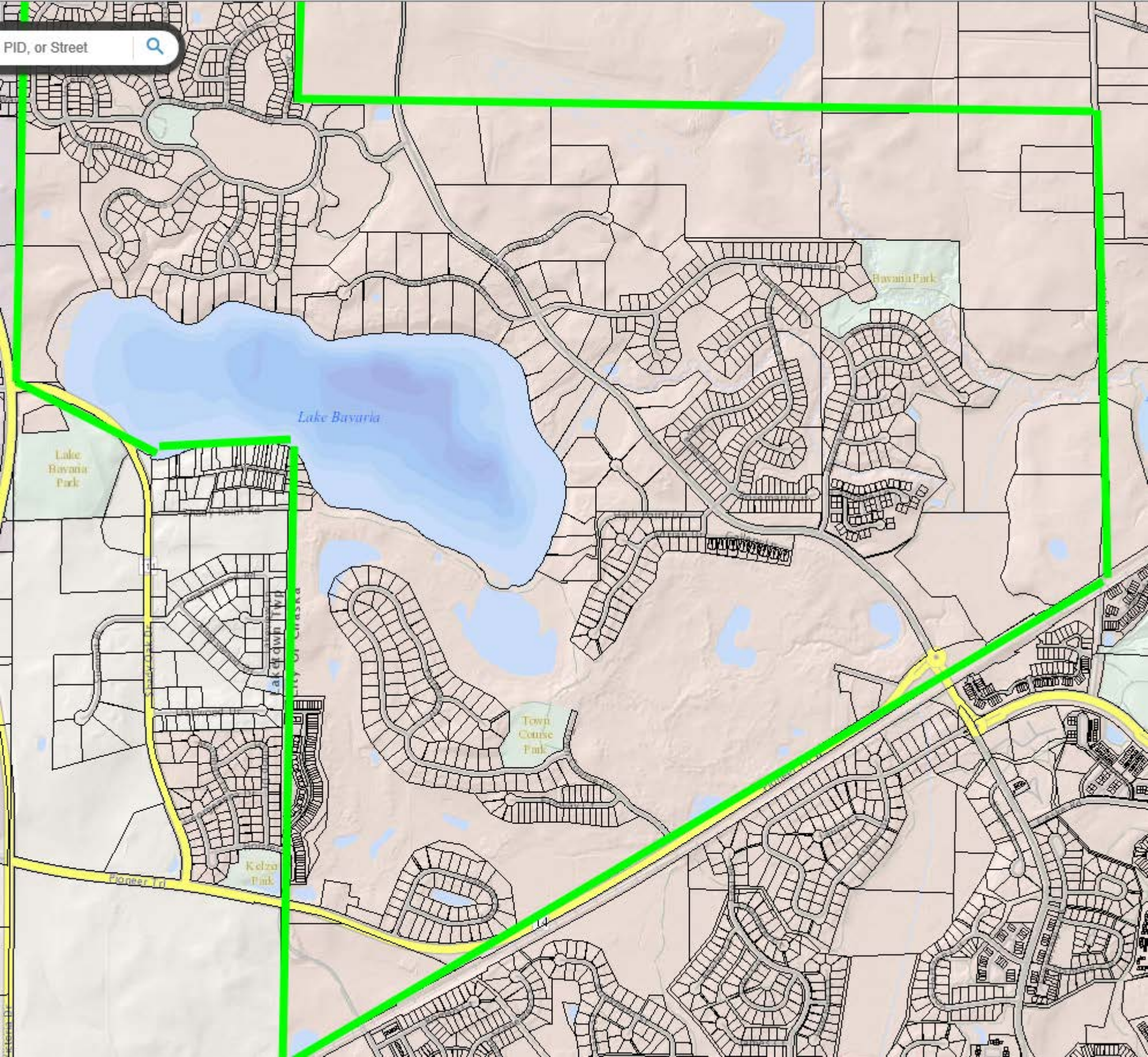

**Note:** Operation of a motorized golf cart within the City limits of Chaska shall be in compliance with the conditions and regulations set forth in Chapter 10, Section 10.20 of the Chaska City Code [Chaska City Code Chapter 10, Section 10.20](#)

### **Conditions of Permit Owner's Responsibility**

1. Only persons at least sixteen (16) years of age with a valid driver's license holders may operate golf carts on City streets.
2. Golf cart may only be operated on roadways designated on permit.
3. The operation of motorized golf carts is expressly prohibited on all public bike trails, walking trails and sidewalks unless designated.
4. Motorized golf carts may only be operated on the designated roadways from sunrise to sunset. They shall not be operated in inclement weather or when visibility is impaired by weather, smoke, fog, or other conditions, or at any time when there is insufficient light to clearly see persons and vehicles on the roadway at a distance of 500 feet.
5. Motorized golf carts must display the slow-moving emblem as described in Minnesota Statutes, Section 169.522 when operated on designated roadways.
6. Motorized golf carts must be equipped with a rear-view mirror.
7. The permit decal must be displayed on the **driver's side portion** of the golf cart at all times.
8. This permit expires on December 31<sup>st</sup>.
